7 HANDLING AND STORAGE

- Handling** : Keep container tightly closed. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. After handling the material, workers should wash hands and face before eating, drinking and smoking. Always comply with health and safety regulations.
- Storage** : Store in original container. Observe label precautions. Store in a cool, well-ventilated area away from incompatible materials and ignition sources. Keep away from oxidizing agents, strong alkaline and acids. No smoking. Containers which have been opened must be carefully resealed and kept upright to prevent leakage.
