## 7 HANDLING AND STORAGE

- Handling** : Keep container tightly closed. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. - Storage** : Store in original container. Observe label precautions. Store in a cool, well-ventilated area away from incompatible materials and ignition sources.
